#### **RESOLUTION NO. 685-2020**

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF THE CITY OF URDANETA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,328,374,491.05 OPERATIVE IN ITS ENTIRETY

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Annual Budget for Calendar Year 2020 involving total appropriations of **P1,328,374,491.05** which was approved on October 29, 2019 through Appropriation Ordinance No. 5, S-2019-22;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The appropriations to cover share in the Health Insurance Premium contributions shall be subject to the provisions of Circular Letter No. 2019-8 dated July 3, 2019 which provides for the new PhilHealth contribution rate:
- 2. The appropriation for Other Bonuses and Allowances and Other Personnel Benefits of officials and employees of Urdaneta City University shall not be disbursed until such time that the circulars granting the same shall be issued by the proper authorities;

- 3. The appropriation for Productivity Incentive Allowance shall be properly classified as Productivity Enhancement Incentive (PEI) and shall be subject to Budget Circular No. 2017-4 dated December 4, 2017;
- 4. The disbursement of appropriation for Performance-Based Bonus (PBB) of officials and employees of Urdaneta City University shall be subject to the provisions of DILG-DBM Joint Memorandum Circular No. 2019-1 dated November 21, 2019;
- 5. All purchases of Motor Vehicles shall be in accordance with the provisions of Administrative Order No. 14, S-2018, as implemented under Budget Circular No. 2019-2 dated March 4, 2019, Administrative Order No. 15 dated May 25, 2011 and Budget Circular No. 2017-1 dated April 26, 2017 amending Budget Circular No. 2016-05 dated August 22, 2016;
- 6. The position title of Assessment Clerk IV under the Office of the City Assessor shall be changed to Assessment Clerk III with salary grade of 9 to conform with the Index of Occupational Services, Position Titles and Salary Grades for Local Governments;
- 7. The effect of the adjusted FY 2020 Internal Revenue Allotment (IRA) shares pursuant to Local Budget Memorandum No. 78-A dated December 17, 2019, particularly the decrease of the IRA of the LGU amounting to P3,055,676.00, will necessitate the prioritization in the implementation of items of appropriation;
- 8. An Ordinance creating the General Services Office shall be submitted;
- 9. All appropriations for development projects (20% development fund) shall be subject to the provisions of DILG-DBM Joint Memorandum Circular No. 2017-1 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects" dated February 22, 2017 amending Joint Memorandum Circular No. 2011-1 dated April 15, 2011;
- 10. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF); and
- 11.All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.
