**RESOLUTION NO. 694-2021**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALEDAR YEAR 2021 OF MAPANDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,061,591.64 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2021 involving total appropriations of P1,061,591.64 which was enacted on July 16, 2021 through Appropriation Ordinance No. 3, S-2021;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources of the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 417 (a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993;
2. That an ordinance creating the position of Tax Mapping Aide I, SG-4 under the Municipal Assessor's Office and Administrative Aide I, SG-1 under the Municipal Agriculture Office shall be submitted; *and*

3. That the creation of positions shall be in accordance with the provisions of Civil Service Commission Memorandum Circular No. 19, S-1992 dated May 7, 1992 as Guidelines and Standards in the Establishment of Organizational Structures and Staffing Pattern in Local Government Units, and that priority shall be given to the creation of mandatory positions.


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


