TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on June 11, 1990, at Lingayen, Pangasinan, the following ordinance was approved:

PROVINCIAL ORDINANCE NO. 06-1990

CREATING SITIO LONGOS INTO A SEPARATE, DISTINCT AND INDEPENDENT BARANGAY TO BE NAMED "BARANGAY LONGOS PROPER", OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN

WHEREAS, this Body is in receipt of a copy of Resolution No. 12-223 series of 1989 of the Sangguniang Bayan of San Fabian, Pangasinan favorably indorsing the petition of the majority of the registered voters of Sitio Longos Proper, for the separation of said sitio from its Mother Barangay and for the creation of the said sitio into an independent, separate and distinct barangay to be named "Barangay Longos Proper" of the Municipality of San Fabian;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangay, all the essential requirements therein are satisfactorily met;

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political diplomats in the area and foster faster delivery of basic services;

WHEREFORE, in view of the foregoing, on motion of SP Member Dionisio C. Antiniw, spontaneously seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to create, as it is hereby created, Sitio Longos Proper into a separate, distinct and independent barangay to be named Barangay Longos Proper, of the Municipality of San Fabian, Pangasinan;

RESOLVED, FURTHER, to request the COMELEC to schedule the holding of a plebiscite in this new barangay within forty five (45) from approval of this ordinance and for the COMELEC to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of this newly created barangay for the official record and for the information of all concerned;

RESOLVED, FINALLY, that copies of this resolution be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, the DLG, Bureau of Lands, PC-INP, COMELEC and DECS for their information and guidance.
