APPROVING RESOLUTION NO. 2020-31 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3, CY 2020, AS EMBODIED IN THE MDC RESOLUTION NUMBER 3, SERIES OF 2020 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2020-31 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on June 11, 2020 by the Municipal Development Council thru MDC Resolution No. 3, S-2020 and was favorably acted upon by the Sangguniang Bayan on June 18, 2020 thru SB Resolution No. 2020-31;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality covers the programs, projects and activities which are proposed to be funded from the Surplus for the period ending December 31, 2019;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P9,040,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2020 which was approved by their Sangguniang Bayan on June 18, 2020 thru Appropriation Ordinance No. 2020-03;
