DECLARING ORDINANCE NO. 2019-008 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE LOCAL INVESTMENT AND INCENTIVE CODE OF STA. BARBARA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2019-008 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, 109, 192 and 447 (a) (2) (ii) and (xii) of RA 7160; RA 7042 (Foreign Investment Act of 1991); RA 7844 (Export Development Act of 1994); RA 7916 (Special Economic Zone Act of 1995);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication and posting pursuant to Sections 59 and 511 (a) of RA 7160;
