APPROVING RESOLUTION NO. 503, S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BAYAMBANG TO FACILITATE THE IMPLEMENTATION OF THE PRIORITY PROGRAM, PROJECTS AND ACTIVITIES INCORPORATED THEREIN DESIGNED TO PROMOTE THE GENERAL WELFARE AND HEALTH OF BAYAMBANGUENOS DURING THE STATE OF NATIONAL HEALTH EMERGENCY DUE TO COVID-19”

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 503, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Bayambang, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 1 for CY 2020 in response to the COVID-19 crisis. This was endorsed by the Council, through MDC Resolution No. 04, S-2020 dated April 20, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 503, S-2020 dated June 08, 2020;

WHEREAS, funding for this Supplemental AIP of the LGU will be sourced from the Bayanihan Grant to Cities and Municipalities (as per Local Budget Circular No. 125 dated April 7, 2020) as embodied in their Supplemental Budget No. 01-2020, FY 2020, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 01, S-2020 dated April 20, 2020. The Appropriation Ordinance was earlier approved by the Sangguniang Panlalawigan on June 1, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
