APPROVING RESOLUTION NO. 2020-241 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE MUNICIPALITY'S REVISED ANNUAL INVESTMENT PROGRAM FOR THE CALENDAR YEAR 2020"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2020-241 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has revised the CY 2020 Annual Investment Program of the municipality to include the programs/projects to be funded from the unexpended balances of MDRRMF for CY 2015-2019. This was endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2020-03 dated April 10, 2020;

WHEREAS, on June 24, 2020, the Sangguniang Bayan approved the Revised Annual Investment Program thru Resolution No. 2020-241. This is in accordance with Item 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-01 dated March 25, 2013 and Item 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020;

WHEREAS, the Revised AIP CY 2020 has now a total investment requirement of P120,961,771.86 as compared to the approved AIP 2020 (P113,060,738.31) due to integration of programs/projects/activities to be funded by the unexpended MDRRMF balance of P7,901,033.55;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
