APPROVING RESOLUTION NO. 87, S-2017 OF THE OF STO. TOMAS, BAYAN SANGGUNIANG **"APPROVING/ADOPTING** PANGASINAN. ENTITLED THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) MUNICIPALITY OF STO. TOMAS. OF THE **PANGASINAN FOR CALENDAR YEAR 2017"** 

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 87, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sto. Tomas, Pangasinan has formulated the municipality's Supplemental Investment Program (SIP-01) S-2017 amounting to P3,463,850.75. This was endorsed through MDC Resolution No. 02-S-2017 dated September 28, 2017 to the Sangguniang Bayan and was subsequently approved by their Sangguniang Bayan thru Resolution No. 87, S-2017 dated October 24, 2017;

WHEREAS, the Supplemental Investment Program (SIP-01) for CY 2017 of Sto. Tomas, Pangasinan mainly covers the granting of Personal Benefits to officials and employees of the local government unit;
