PROVINCIAL RESOLUTION NO. 725-2021

URGING THE DEPARTMENT OF HEALTH TO STRICTLY ADHERE TO THE MECHANICS AND GUIDELINES SETFORTH BY THE OFFICE OF THE PRESIDENT AND DEPARTMENT OF BUDGET AND MANAGEMENT ON THE GRANT OF SPECIAL RISK ALLOWANCE AND ACTIVE HAZARD DUTY PAY TO HEALTHCARE WORKERS

WHEREAS, Proclamation No. 922, Series of 2020 declared a State of Public Health Emergency in recognition of the COVID-19 public health event as a threat to national security, and prompted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

WHEREAS, RA No. 11494, otherwise known as the "Bayanihan to Recover as One", affirmed the existence of a continuing national emergency in view of the unabated spread of COVID-19 and the economic disruption ensuing from it;

WHEREAS, Administrative Order No. 35 issued by the Office of the President authorized the grant of Active Hazard Duty Pay to Human Resources for Health (HRHs) serving in the frontlines during the state of a national emergency;

WHEREAS, Administrative Order No. 36 issued by the Office of the President also authorized the grant of Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the state of national emergency;

WHEREAS, Administrative Order No. 42 of the Office of the President authorized the extension until the end of June this year the grant of Special Risk Allowance (SRA) to frontline public health workers;
