**RESOLUTION NO. 750-2020**

**DECLARING ORDINANCE NO. 2019-12 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING BACKFILLING/SITE FILLING AND REQUIRING ALL CONTRACTORS/DEVELOPERS AND/OR OWNERS OF PRIVATE INFRASTRUCTURES PROJECTS, MALLS, SUPERMARKETS, GASOLINE STATIONS, BUILDINGS, SUBDIVISIONS, AND OTHER REAL ESTATE DEVELOPMENT PROJECTS TO SECURE A LOCATIONAL CLEARANCE AND/OR DEVELOPMENT PERMIT FROM THE SANGGUNIANG PANLUNGSOD OF THE CITY OF ALAMINOS, PANGASINAN PRIOR TO COMMENCING CONSTRUCTION AND/OR EARTH WORKS AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2019-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 458 (a) (2) (ix) and (x) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian has complied with the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 and 511 of RA 7160;


