RESOLUTION NO. 761-2020

DECLARING ORDINANCE NO. 136, S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING AN EDUCATIONAL ASSISTANCE PROGRAM IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND APPROPRIATING FUNDS RELATIVE THERETO" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 136, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iv) of RA 7160; RA No. 109311 otherwise known as the "Universal Access to Quality Tertiary Education Act"; RA No. 10648 entitled: "An Act Promoting Scholarship Grants to Top Graduates of all Public High Schools in the State Universities and Colleges and Appropriating Funds Therefor";

WHEREAS, subject ordinance shall take effect after compliance with the posting requirement pursuant to Section 59 of RA 7160;
