APPROVING RESOLUTION NO. 027-2020 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2020 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 027-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Labrador, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on June 22, 2020 by the Municipal Development Council thru Resolution No. 02-S-2020 and was favorably acted upon by the Sangguniang Bayan on July 13, 2020 thru SB Resolution No. 027-2020;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses of various municipal offices and implementation of infrastructure project of the municipality;
