APPROVING RESOLUTION NO. 50-S-2021 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED, "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 2 CY 2021"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its SB Resolution No. 50-S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on June 21, 2021 by the Municipal Development Council through MDC Resolution No. 6, Series of 2021;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers the fund augmentation for the personal services (granting of Performance-Based Bonus to all qualified officials and employees), fund augmentation for Maintenance and Other Operating Expenses of some municipal offices and implementation of disaster risk reduction and management programs/activities of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P3,745,932.34. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 2, Series of 2021, which was passed and approved by their Sangguniang Bayan on July 12, 2021 through Appropriation Ordinance No. 02, Series of 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;
