**RESOLUTION NO. 77-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 5 FOR  
CALENDAR YEAR 2021 OF THE CITY OF ALAMINOS,  
PANGASINAN INVOLVING A TOTAL APPROPRIATION  
OF P36,087,251.08, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 5 for Calendar Year 2021 involving total appropriations of P36,087,251.08, which was enacted on November 9, 2021 through Appropriation Ordinance No. 2021-05;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
3. That all programs and projects and activities shall be in accordance with the approved Local Development Plan and FY 2021 Supplemental Investment Program of the Municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular N0. 1, series of 2007 dated 08 March 2007 and DILG-DBM Joint Memorandum Circular No. 01 dated 27 March 2020; and
4. That all the salaries of the newly created positions shall be adjusted in accordance with the provisions of the Local Budget Circular No. 132 dated January 6, 2021 (Implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to R.A. No. 11466).


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


