THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on September 17, 1990, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 9-1990

CREATING SITIOS LAOG, MANCOPAPEYAN, MAPITA AND ALILING IN BARANGAY POOMBOA, AGUILAR, PANGASINAN INTO A SEPARATE, DISTINCT AND INDEPENDENT BARANGAY TO BE NAMED "BARANGAY LAOG" OF THE MUNICIPALITY OF AGUILAR

WHEREAS, this Body is in receipt of a copy of Resolution No. 60, Series of 1990 of the Sangguniang Bayan of Aguilar, Pangasinan favorably endorsing the petition of the majority of the registered voters of Sitios Laog, Mancopapeyan, Mapita and Aliling, for the separation of said sitios from its Mother Barangay and for the creation of the said sitios into an independent, separate and distinct barangay to be named "Barangay Laog" of the Municipality of Aguilar, Pangasinan;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangay, all the essential requirements therein are satisfactorily met;

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political development in area and foster faster delivery of basic services;

WHEREFORE, in view of the foregoing, on motion of Sangguniang Panlalawigan Member Jose B. Castillo, duly seconded by Sangguniang Panlalawigan Members Editha G. Domestica and Roberts G. Sison, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to create, as it is hereby created, Sitios Laog, Mancopapeyan, Mapita and Aliling into a separate, distinct and independent barangay to be named "Barangay Laog", of the Municipality of Aguilar, Pangasinan;


RESOLVED, FURTHER, to request the COMELEC to schedule the holding of a plebiscite in this new barangay within forty five (45) days from approval of this ordinance and for the COMELEC to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of this newly created barangay for the official record and for the information of all concerned;


