**RESOLUTION NO. 801-2020**

**DECLARING ORDINANCE NO. 2, S-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING A PERSON UNDER MONITORING (PUM) FOR A COMPULSORY HOME QUARANTINE AND IMPOSING PENALTIES IN VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 2, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xii) of RA 7160; Department of Health Department Circular No. 2020-0090, or the "Interim Guidelines on the Management of Persons Under Monitoring (PUMs) Suspected of Corona Virus Disease 2019 (COVID-19) for Home Quarantine; Department of the Interior and Local Government Memorandum Circular No. 2020-087 regarding the management of Locally Stranded Individuals (LSIs) and Returning Overseas Filipinos (ROFs);

**WHEREAS**, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her letter dated August 14, 2020;

**WHEREAS**, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


