#### **RESOLUTION NO. 802-2020**

DECLARING ORDINANCE NO. 86, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE UPDATING THE GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 86, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, 17 (a) (iv) of RA 7160; the Gender and Development Code of the Philippines enshrined in the 1987 Philippine Constitutions; RA No. 71192 (An Act Promoting the Integration of Women as Full and Equal Partners of Men in Development and Nation Building and For Other Purposes); and RA No. 9710 (Magna Carta of Women);

**WHEREAS**, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;
