RESOLUTION NO. 802-2021

DECLARING MUNICIPAL ORDINANCE NO. 120, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING TAMPERING, FORGING, ALTERING OR REPRODUCING WITHOUT AUTHORITY OF AUTHENTIC COVID-19 VACCINATION CARDS AS WELL AS THOSE WHO PRESENT THE SAME, AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 120, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 (a) (i) (iii) (5) (xii) of R.A. No. 7160, DILG Advisory dated July 16, 2021 re: Authenticity of Vaccination Cards, and Section 8 (g) of Executive Order No. 0102-2021 of the Provincial Government of Pangasinan;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


