DECLARING ORDINANCE NO. 07, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF MUNICIPAL BUDGET OFFICER I UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER IN THE MUNICIPALITY OF INFANTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 07, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (vii) of RA 7160;

WHEREAS, the position title should be changed to Administrative Officer II (Budget Officer I) to conform with the provisions of Budget Circular No. 2004-3 dated March 6, 2004 entitled "Conversion of Positions Performing Staff/Non-Technical Positions";

WHEREAS, the plantilla under the Office of the Municipal Budget Officer should be revised to include newly-created position and a Supplemental Budget for the salaries and allowances of the new position should be prepared;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
