## RESOLUTION NO. 814-2021

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2021 OF SAN NICOLAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P4,290,232.88 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of P4,290,232.88, which was enacted on August 23, 2021 through Appropriation Ordinance No. 1, Series of 2021;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 417(a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993; and

2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated 08 March 2007.
