PROVINCIAL RESOLUTION NO. 82-2020

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY THE PENR OFFICER FOR THE ADOPTION OF THE PROVINCIAL FORESHORE AREA DEVELOPMENT AND MANAGEMENT PLAN OF PANGASINAN

WHEREAS, the Provincial Foreshore Area Development and Management Plan of Pangasinan (PFADMP) was formulated through the collective efforts of the Department of Environment and Natural Resources (DENR), the Provincial Government of Pangasinan, 14 coastal local government units of Pangasinan, national government agencies and other stakeholders whom were referred to as owners and implementers of the plan;

WHEREAS, the Provincial Foreshore Area Development and Management Plan recommended by the DENR Regional Technical Working Group was presented to the stakeholders during the workshop culminated on August 19-21, 2019 at Consuelo Resort and Hotel, Lingayen, Pangasinan;

WHEREAS, the DENR together with other government agencies and the 14 enabling local government units mutually agreed to be bound in partnership to implement the plan towards a common goal of attaining the vision which is to have "A sustainable foreshore and one of the best ecological destinations valued, safeguarded and enjoyed by all";

WHEREAS, the creation of the Foreshore Management Board is the first step towards the commitment of the DENR and its stakeholders to improve, develop, manage, protect and conserve the foreshore areas of the Province of Pangasinan;
