APPROVING RESOLUTION NO. 20-041 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “REALIGNING THE AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND PESOS (P1,700,000.00) FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND UNDER PROJECTS TITLED: 1) TRAINING OF EMERGENCY AND RESCUE TEAMS IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) AND 2) CONDUCT OF SEMINARS AND DRILL IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) TO PROJECT TITLED: PROCUREMENT OF DISASTER EQUIPMENT/SUPPLIES AMOUNTING TO ONE MILLION SEVEN HUNDRED THOUSAND PESOS (P1,700,000.00)”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-041 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan proposed to the Sangguniang Panlungsod the realignment of the sum of P1,700,000.00 from the LDRRM Fund of the LGU. This was endorsed by the Council thru CDC Resolution No. 06-20 (Series of 2020) dated July 15, 2020 to the Sangguniang Panlungsod for approval;

WHEREAS, the Sangguniang Panlungsod approved said proposal for realignment through Sangguniang Panlungsod Resolution No. 20-041 dated July 20, 2020;
