**APPROVING RESOLUTION NO. 20-75 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION 2020-03 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3 FOR FY 2020 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 20-75 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sta. Maria, Pangasinan has formulated, adopted and endorsed the municipality’s Supplemental Annual Investment Program (SAIP) No. 3 thru MDC Resolution No. 2020-03 dated June 10, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on July 28, 2020 through Resolution No. 20-75. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 3 has an investment requirement amounting to P6,575,131.70 which covers the funding of terminal leave, salaries and other benefits of a new position, implementation of new development project and fund augmentation for disaster risk reduction and management programs and maintenance and other operating expenses of some offices of the municipality;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
