DECLARING MUNICIPAL ORDINANCE NO. 13-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE PLANTILLA POSITION OF MUNICIPAL RISK REDUCTION AND MANAGEMENT OFFICER V (LDRRMO V) OF LGU MANAOAG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


