DECLARING MUNICIPAL ORDINANCE NO. 2020-06 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "OTHERWISE KNOWN AS THE OMNIBUS ORDINANCE IMPOSING MINIMUM HEALTH STANDARDS DUE TO COVID 19 PANDEMIC UNDER THE "NEW NORMAL" AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF IN ACCORDANCE WITH THE PREVAILING QUARANTINE STATUS IN THE MUNICIPALITY OF BOLINAO" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2020-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 447 (a) (1) (iii), (5) (xii) of RA 7160; Presidential Proclamation No. 922, S-2020; DILG Memorandum No. 2020-071; Provincial Ordinance No. 240-2020; Department of Transportation Memorandum Circular No. 2020-014; Executive Order No. 0033-2020 and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, the Sangguniang Bayan of Bolinao shall consider the points raised by the Provincial Legal Officer stated in her opinion dated September 2, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
