CERTIFICATION

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on June 21, 1999, at Lingayen, Pangasinan, the following ordinance was approved:

EXPLANATORY NOTE

WHEREAS, the Local Government Unit is composed primarily of the Executive and the Legislative branches;

WHEREAS, the Executive and Legislative branches are inseparable partners in local governance, the first being the implementor and the latter, the law maker;

WHEREAS, there are many instances whereby the two branches of government are in disagreement with each other especially on urgent and vital issues and policies and programs of government, resulting to retrogression of the local government unit concerned;

WHEREAS, there should be adopted a formula to resolve these discords and disagreements so that the local government unit can move forward instead of sliding backward;

WHEREFORE, in view of the foregoing, on motion of SP Members Alfonso C. Bince, Jr. and Angel G. Baniqued, co-authored by SP Member Mac Arthur C. Samson, Jr., unanimously seconded,

BE IT ENACTED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED,

PROVINCIAL ORDINANCE NO. 85-99

AN ORDINANCE CREATING THE JOINT EXECUTIVE AND LEGISLATIVE COORDINATING COUNCIL

SECTION 1. **PURPOSE**. The Joint Executive and Legislative Coordinating Council is hereby created to assure effective coordination and harmonious relationship between the Executive and Legislative branches of the province of Pangasinan.

SECTION 2. **COMPOSITION**. This Body shall be composed of the following:

Chairman - Provincial Governor
Vice Chairman- Provincial Vice Governor
Secretary - Provincial Administrator

From the Legislative Branch - Presiding Officer Pro Tempore
Majority Floor Leader
Minority Floor Leader
Assistant Majority Floor Leader
Assistant Minority Floor Leader


From the Executive Branch - Provincial Legal Officer

SECTION 3. **REVOLVING MEMBERSHIP**


- a.) In addition to the composition enumerated above, the Department Head concerned in certain issues becomes a member in an Ad Hoc capacity;
- b.) The Chairman of the Committee of the Sangguniang Panlalawigan whose Committee is concerned or involved in relevant issues is likewise an automatic member.


SECTION 4. **TIME AND PLACE OF MEETING**. The Executive and Legislative Coordinating Council shall meet at least once a month or when exigency arises at the Urduja House or in any other venue or designated place to be determined by the Chairman or majority of its members.

SECTION 5. **EFFECTIVITY**. This ordinance shall take effect on July 1, 1999.
