**RESOLUTION NO. 859-2021**

**DECLARING ORDINANCE NO. 162, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE SHIELD ALONG WITH FACE MASK BY ALL PERSONS IN PUBLIC PLACES, PUBLIC TRANSPORTATION SYSTEM AND PRIVATE COMMERCIAL ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BASISTA, PANGASINAN DURING THE PERIOD OF COMMUNITY QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 162, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 (5) (xii) of R.A. No. 7160, Section 8 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines (Updated as of September 23, 2021), Pangasinan Provincial Ordinance Nos. 235-2020, as amended and 242-2020;




**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 162, S-2021 of the Sangguniang Bayan of Basista, Pangasinan, entitled “An Ordinance requiring the mandatory wearing of face shield along with face mask by all persons in public places, public transportation system and private commercial establishments within the territorial jurisdiction of the Municipality of Basista, Pangasinan during the period of community quarantine or until lifted, and providing penalties for violation thereof” as within the conferred powers of the Sanggunian to enact;
