APPROVING RESOLUTION NO. 2018-376-176 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3 FOR THE CALENDAR YEAR 2018 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2018-376-176 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality's Supplemental Investment Program No. 3 which was endorsed thru MDC Resolution No. 2018-06 dated December 10, 2018 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan thru Resolution No. 2018-376-176 dated December 12, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;

WHEREAS, the Supplemental Investment Program of the municipality pertains to the Construction of Irrigation Canals which will be funded from the Performance Challenge Fund amounting to P3,200,000.00. The identified project is a new project and was not included in the 2018 approved Annual and Supplemental Investment Programs of the municipality;
