RESOLUTION NO. 874-2021

DECLARING MUNICIPAL ORDINANCE NO. 10-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “AN ORDINANCE IMPOSING THE REGISTRATION AND LICENSING ORDINANCE OF FISHING BANCA, THREE (3) GROSS TONNAGE AND BELOW OF THE MUNICIPALITY OF BURGOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Municipal Ordinance No. 10, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 132, 149 (3) and 447(a) (3) (i) of R.A. No. 7160; R.A. No. 10601 otherwise known as “Agriculture and Fisheries Mechanization Law”; Executive Order No. 305 or the “Devolving to the Municipality and City Government the Registration of Fishing Vessels Three (3) Gross Tonnage Below” and R.A. No. 8550 known as the “Philippine Fisheries Code of 1998”;

WHEREAS, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c), and 511(a) of RA 7160 are complied with;




