RESOLUTION NO. 879-2020

DECLARING ORDINANCE NO. 08-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE POLICIES, RULES AND OPERATIONS OF TRICYCLES, PEDICABS AND E-TRIKES IN THE MUNICIPALITY OF ROSALES, PANGASINAN DURING TIMES OF COMMUNITY QUARANTINE AND SIMILAR CIRCUMSTANCES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 08-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (vi) of RA 7160 and Section 11 of Executive Order No. 0033-2020, otherwise known as the "Implementing Guidelines on the Modified Community Quarantine in the Province of Pangasinan;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


