RESOLUTION NO. 889-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 7 FOR CALENDAR YEAR 2020 OF BINMALEY, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P18,176,274.96 OPERATIVE IN PART

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Supplemental Budget no. 7 for Calendar Year 2020 involving total appropriations of **P18,176,274.96** which was approved on September 1, 2020 through Appropriation Ordinance No. 7, S-2020;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The Personal Services appropriation for the upgrading of the position of Nurse II with Salary Grade 15 to Salary Grade 17 shall not be allowed as the said position was not upgraded under the Budget Circular No. 2020-4 of the Department of Budget and Management dated July 7, 2020;
- 2. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;

- 3. The appropriation for Other Maintenance and Operating Expenses shall cover only other expenses not otherwise classified under any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015;
- 4. The appropriation for Public Affairs Fund shall be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Sections 305 (b) and 335 of RA 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015;
- 5. The utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DILG-DBM Joint Memorandum Circular No. 2017-1 dated February 22, 2017;
- All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007; and
- 7. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN PART the Supplemental Budget no.** 7 for **Calendar Year 2020 of Binmaley, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley;
