RESOLUTION NO. 891-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2020 OF BUGALLON, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P4,503,086.64 OPERATIVE IN PART

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2020 involving total appropriations of **P4,503,086.64** which was approved on August 10, 2020 through Appropriation Ordinance No. 2020-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The Personal Services appropriation for the upgrading of the positions of Nurse III, Salary Grade 17 to Salary Grade 19 and Nurse IV, Salary Grade 19 to Salary Grade 20 shall not be allowed as the said positions are not upgraded under the Budget Circular No. 2020-4 of the Department of Budget and Management dated July 7, 2020;
- 2. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;

- 3. The excess appropriation for Personal Services shall be subject to the provisions of Section 325 (a) of RA 7160;
- 4. The upgrading of the position of Nurse I, Salary Grade 11 to Salary Grade 15 shall be subject to the provisions of Budget Circular No. 2020-4 of the Department of Budget and Management dated July 7, 2020;
- 5. The grant of Hazard Pay to government personnel who physically reported for work during the period of implementation of an Enhanced Community Quarantine relative to the COVID-19 Outbreak shall be in accordance with the provisions of Administrative Order No. 26 by the President of the Philippines dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020;
- 6. The grant of Special Risk Allowance (SRA) to frontliner Public Health Workers of the municipality shall be subject to DBM Budget Circular No. 2020-2 dated April 7, 2020;
- 7. The purchase of motor vehicle shall be in accordance with the provisions of Administrative Order No. 14, S-2018, as implemented under Budget Circular No. 2019-2 dated March 4, 2019, amending Administrative Order No. 15 dated May 25, 2011, and Budget Circular No. 2017-1 dated April 26, 2017 amending Budget Circular No. 2016-5 dated August 22, 2016;
- 8. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; and
- All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;
