APPROVING RESOLUTION NO. 241, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "STRONGLY ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 04, SERIES OF 2021, ENTITLED: RESOLUTION RECOMMENDING THE REALIGNMENT NO. 2 OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (MDRRMIFIP) CY 2021 AMOUNTING TO SEVEN HUNDRED FORTY THOUSAND NINE HUNDRED FIFTY-FOUR PESOS (P740,954.00)"

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the realigned Local Disaster Risk Reduction Management Fund 2021 is proposed to fund new disaster risk reduction and management projects and to augment funding of an existing DRRM project in the previously approved AIP CY 2021 of the Municipality of Binmaley;
