APPROVING RESOLUTION NO. 2018-110 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2018-003 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF FOUR MILLION THREE HUNDRED TWENTY EIGHT THOUSAND ONE HUNDRED FIFTY FIVE PESOS (P4,328,155.00)”

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2018-11 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 2 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2018-06 dated December 11, 2018. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2018-110 dated December 27, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;
