APPROVING RESOLUTION NO. 12-21-85 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED, "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM 4 (SIP 4) SERIES OF 2021 OF THE LGU MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its SB Resolution No. 12-21-85 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Mabini, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 15, 2021 through MDC Executive Committee Resolution No. 07, Series of 2021;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality covers fund augmentation for the Personal Services (Granting of Collective Negotiation Agreement Incentive and Service Recognition Incentive to all municipal officials and employees), Maintenance and Other Operating Expenses of some municipal offices and implementation of disaster risk reduction activities and other programs of the LGU;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P4,465, 201.50. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 3, CY 2021, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, Series of 2021 on December 20, 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mabini, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and cosponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was-
