RESOLUTION NO. 915-2020

DECLARING ORDINANCE NO. 02-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A PORTION OF LAND CONTAINING AN AREA OF EIGHT HUNDRED (800) SQUARE METERS, MORE OR LESS, FROM A PARCEL OF LAND WITH A TOTAL AREA OF TWO THOUSAND SIX HUNDRED SEVENTY SEVEN (2,677) SQUARE METERS, COVERED BY TCT NO. 028-2019000611, DULY OWNED BY MR. JOSELITO CARIÑO, MRS. LILIBETH CARIÑO, AND MR. JOSHUA CARIÑO, LOCATED AT BARANGAY SAN BARTOLOME, ROSALES, PANGASINAN, FROM AGRICULTURAL TO COMMERCIAL, SUBJECT TO APPLICABLE NATIONAL AND LOCAL LAWS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 02-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, and Provincial Planning and Development Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 20 (a) (2) (3) (c) (d) and (e) and Section 447 (a) (2) (viii) of RA 7160;

WHEREAS, however, a Clearance for Reclassification from the Department of Agriculture and Department of Agrarian Reform should be complied with accordingly;




RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 02-2020 of the Sangguniang Bayan of **Rosales**, Pangasinan, entitled “An Ordinance reclassifying a portion of land containing an area of Eight Hundred (800) square meters, more or less, from a parcel of land with a total area of Two Thousand Six Hundred Seventy Seven (2,677) square meters, covered by TCT No. 028-2019000611, duly owned by Mr. Joselito Cariño, Mrs. Lilibeth Cariño, and Mr. Joshua Cariño, located at Barangay San Bartolome, Rosales, Pangasinan, from agricultural to commercial, subject to applicable national and local laws” as within the conferred powers of the Sangguniang Bayan to enact;
