**PROVINCIAL RESOLUTION NO. 934-2020**

**AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO SIGN THE DEED OF DONATION AND RECEIVE SETS OF PERSONAL PROTECTIVE EQUIPMENT FROM THE NATIONAL GRID CORPORATION OF THE PHILIPPINES**

**WHEREAS**, one of the primordial concerns of the provincial government of Pangasinan is to address health issues and provide medical service needs of the people, especially during this period of public health emergency crisis;

**WHEREAS**, the National Grid Corporation of the Philippines, a privately owned corporation in charge of operating, maintaining, and developing the country's state-owned power grid, has manifested its desire to support the Provincial Government of Pangasinan through its P1 Billion donation to the national government's COVID-19 relief and response efforts;

**WHEREAS**, the Province of Pangasinan will be the recipient of sets of Personal Protective Equipment from the National Grid Corporation of the Philippines in the form of a donation and hereby expresses its willingness to accept the same;




