RESOLUTION NO. 948-2020

DECLARING MUNICIPAL ORDINANCE NO. 131-150920 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING THE USE OF FACE SHIELD ON TOP OF FACE MASK IN ALL PUBLIC PLACES AND PRIVATE ESTABLISHMENTS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 131-150920 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to the General Welfare Clause of Section 16 and Section 447 (a) (1) (iii) (5) (xii) of RA 7160, DILG Memorandum Circular No. 2020-071 on the Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places, Section 8 of IATF's Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments dated June 3, 2020 and Memorandum Circular No. 2020-014 of the Department of Transportation dated August 5, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREAS, however, the Sanggunian shall consider the observation of the Provincial Legal Officer in her written opinion dated October 7, 2020;


