AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH TEAM ENERGY FOUNDATION, INC. FOR THE PROVISION OF SIX (6) UNITS FOUR-SEATER ELECTRIC VEHICLES TO THE PROVINCE OF PANGASINAN

WHEREAS, the Team Energy Foundation, Inc. has been steadfast in helping the Provincial Government of Pangasinan implement projects that are beneficial to the Province and its people;

WHEREAS, the Team Energy Foundation, Inc. will provide six (6) units four-seater electric vehicles to the Province of Pangasinan with an estimated total project cost of P1,043,678.00);

WHEREAS, the vehicles are designed to be environmentally friendly that will be used in the mobility of provincial employees and transfer of materials within and among the various offices in the different buildings of the Capitol Complex;

WHEREAS, the Province of Pangasinan as a host province to the Sual Coal-Fired Thermal Power Plant will greatly benefit from this project;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and the Team Energy Foundation, Inc., represented by its Vice-President, Ms. Maria Teresa C. Lopez;


