## **RESOLUTION NO. 975-2020**

DECLARING MUNICIPAL ORDINANCE NO. 06, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FREE TEMPORARY SHELTER/ACCOMMODATION FOR HEALTH WORKERS WHO ARE CATERING TO CORONA VIRUS DISEASE (COVID-19) PATIENTS IN THE MUNICIPALITY OF BANI, PANGASINAN AMID COVID-19 PANDEMIC" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 06, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 26 of RA No. 7305 or the Magna Carta of Public Health Workers; Section 3 of Proclamation No. 929 and Inter-Agency Task Force Resolution No. 19; DILG Memorandum Circular No. 2020-072 dated April 11, 2020;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer stated in her opinion dated October 19, 2020;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirement of posting pursuant to Section 59 (a) of RA 7160;
