APPROVING RESOLUTION NO. 21-37 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021-02 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 FOR FY 2021 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its SB Resolution No. 21-37 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, on July 8, 2021, the Local Development Council of Sta. Maria, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 1 through MDC Resolution No. 2021-2 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program No. 01 with an investment requirement amounting to Php7,598,304.60 covers the implementation of the 1st tranche compensation adjustment, fund augmentation for maintenance and other operating expenses, disaster risk reduction management activities and implementation of development project;
