APPROVING RESOLUTION NO. 72, S-2021 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its SB Resolution No. 72, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

**WHEREAS,** the Local Development Council of Infanta, Pangasinan had identified items in their Supplemental Investment Program for CY 2021. This was endorsed to the Sangguniang Bayan for approval on October 1, 2021 through MDC Resolution No. 72, S-2021:

**WHEREAS**, the Second Supplemental Investment Program of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices;

**WHEREAS**, the proposed Supplemental Investment Program has an investment requirement of P2,917,061.65. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 02 for Calendar Year 2021, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, S-2021 on October 13, 202;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;
