## **RESOLUTION NO. 998-2021**

DECLARING MUNICIPAL ORDINANCE NO. 2021-06 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING ONE VACANT POSITION AND CREATING ONE NEW POSITION IN THE MUNICIPALITY OF BUGALLON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Ordinance No. 2021-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
